Memorandum of Understanding

This Memorandum of Understanding (hereinafter called as the 'MoU') entered into 30 June, 2018 at Nashik between the following parties:

1. Nashik Shikshan Prasarak Mandal's Late Bindu Ramrao Deshmukh Arts and Commerce Mahila Mahavidyalaya, Nashik Road through its Principal, Dr Leena Pandhare (here after referred as Party of First Part).

2. Junior Chamber International: JCI (JCI Nashik Road, Zone XIII) through its President, Jc. Bharat N. Nimse (here after referred as Party of Second Part).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

Preamble:

As it is given to the understanding of the First Party that the JCI Active Citizen Framework is a methodology for running sustainable, needs-based projects that create measurable results in communities. The process start with assessing local needs, engaging partners to share resources and strengths, conducting action-oriented projects and finally monitoring and evaluating results to ensure tangible, effective positive impact. Further, the JCI members use the three stages of community development, health and wellness, education and economic empowerment and sustainability to determine local needs, form solutions and take action. The JCI Active Citizen Framework empowers young people to create impact for a better world. JCI members unite at JCI Events to expand their impact through dynamic workshops, programs and trainings that inspire global collaboration for a better world. JCI members take initiative to solve local challenges and focus on sustainable impact locally and globally.

In view of the above, the objective of this MoU is to impart training for under graduate and post graduate students in the field of Personality Development, Soft skills (Life skills), Entrepreneur Training and Employability Skills as part of social responsibility.

The training in the said area will be implemented in the college and based on the following terms and conditions.

It is hereby agreed as follows:

1. Junior Chamber International: JCI (JCI Nashik Road, Zone XIII) i.e. Party of Second Part will train the students in Personality Development, Soft skills (Life skills), Entrepreneur Training and Employability Skills.

2. The number of students trained would depend on the streams availability pool in the college i.e. Party of First Part

3. Party of First Part will assign a coordinator for this project who will engage with the coordinator of the Party of Second Part for the smooth running of the activities.

4. Students will have to register and fill up a form to be eligible for the training offered by the Party of Second Part with necessary documents.

5. Trainers will be deployed by Party of Second Part and attendance will be administered and the same shall be furnished by the Party of First Part.

- 6. The training workshops /programmes/ activities shall be conducted by the parties in the college premises i.e. either in class rooms/ computer lab / Seminar hall etc. The Party of Second Part can use the computer lab made available by the Party of First Part.
- 7. The Party of First Part will provide the premises, computer labs electricity, LCD projects, stationery, copies of study material and other standard infrastructure.
- 8. The 'Parties' will conduct two modules in a year. However, if required, the frequency of the conduct of the modules can be extended after mutual understanding of the parties.
- 9. It will be feasible to delimit the intake of students up to 50. However, considering the context the number can be extended.

The name of college and logo shall appear on the cover page of the Study Material (banner, handouts etc.) along with the name of JCI.

Review

A review of the MoU will be undertaken once after every completed academic cycle to evaluate the progress made and modifications will be incorporated, if required, through mutual consent of both parties.

Validity

This MoU shall remain valid for a period of one year from the date mentioned herein viz. 30 June, 2018 and shall cease to be in force on and after 29 June, 2019.

This MoU may be renewed or extended for a further period by mutual consent of the parties. However, a final review will be taken up, apart from the review for every year, so as to determine the necessary changes and the formation of new MOU thereafter. The decision in this regard will be finalized by the college and communicated to JCI thereafter.

Termination

Notwithstanding any other provision herein, if either party fails or refuses to perform the work and associated duties pursuant to the terms and conditions of this MoU, the affected party may terminate this MoU by two months' notice in writing sent by prepaid registered post to the other at the address given above, or at an address the party has designated in writing.

This MoU shall be interpreted and enforced according to the laws of the State in force from time to time. The Jurisdiction shall be at Nashik, for the purpose of this document.
