Qualitative analysis of Criterion 1

1.1.1 The college offers B.A., B.Com and two PG Programmes. Students are given orientation about the courses in the beginning of the Academic year. Institution follows a well planned and documented process in its curriculum delivery. Credit Semester System is followed in P.G Programs only. Being an affiliated college, it follows the curriculum designed by the affiliating University. Each teacher prepares a term-wise teaching plan in view of the total teaching days available in the academic session. Each department prepares its annual plan for the curricular, Co-curricular and extra-curricular activities. There is an Annual calendar committee which prepares the annual academic Calendar incorporating all departmental activities. Academic Diary is maintained by individual teacher which is checked by the Principal. The implementation of the annual plan of the department is reflected in the diary. The syllabus covered and the total number of lectures conducted for each subject is also mentioned in the diary. One PG programme is started in 2013-14, in the post accreditation period but is yet to get enough takers. Limited number of programs and subject options are offered.

Some teachers have contributed to curriculum development as members of the research Board of YCMOU, Gondwana University and Savitribai Phule Pune University.

Physical Education is introduced as a compulsory subject for first year students since 2016.

1.3.1.Environmental Awareness course has been introduced by the University in the Curriculum for Second Year students.. Professional ethics and Human values are integrated into the syllabus of some of the courses. Gender related issues are also discussed during many co-curricular programmes. The faculty uses various student centric activities related to academics. Even co-curricular activities are organised for the development of **insight learning** and **learning by doing** in students.

- 2.2.Slow and Advanced learners are identified through class room interaction and unit tests. The college conducts a course in English Grammar & Phonetics and Bridge course in Accounting . For improving the standard of slow learners practice tests and assignments are given to slow learners under 'Student Academy''. Advanced learners benefit by lectures by external experts. There is a Special Guidane Scheme under which eminent teachers from outside give lectures specially in English, Economics and Accountancy subjects.
- 2.3.1. M.Com students carry out Project work. In association with Government Library, a programme called "Vachan Prakalp" is in force in which students are motivated to read books beyond curriculum and asked to write book reviews. Students also participate in the University's research based programme "Avishkar." Case studies, Student centric methods like Seminar, Group Discussions, Computerized Commerce Quiz, Publication of Wall Paper, Presentation of Research Paper, Poster Presentation, field visits, Mock Parliament etc. enhance the learning experience. Applied Marathi is taught using newspaper clippings and article.
- 2.3.4.Predominantly lecture method is followed, supplemented with ICT based teaching. University sponsored lectures by experts are also conducted. Some usual participative learning strategies like group discussions, debates etc. are followed. Innovation and creativity in teaching methods are not otherwise visible. Students should be exposed to You Tube Lectures and self learning portals like Swayam,e-Pathashala under MOOCs.

- 2.5.1. In general, Internal Valuation is as per the University norms and pattern Unit tests twice a year and home assignments are in practice. College level committee is reponsible for the smooth conduct of the examination with vigilance squad and CCTV surveilance. At the institutional level College need to try out modern methods of evaluation like MCQs, CBT(Computer Based Tests), Open Book tests, Online examinations which will help the students to compete at global and national levels.
- 2.5.3.University has provision for Verification of marks, reassessment, revaluation and acquisition of photocopy of answer sheets. Grievances are routed through college examination committee.

At the college level answer sheets are discussed and analysed in the "Open House" and grievances if any is redressed instantly.

- 2.5.4. Academic calendar including the conduct of the examinatons is strictly followed.
- 2.6.1. Programme outcomes and course outcomes for all programmes are stated in the syllabus, prospectus and also on the website. At the counselling for admissions and also at the Induction Programme for the freshers, these things are told to the students.
- 2.6.Program outcomes, course outcomes are evaluated with the help of evaluation methods practised by the University. The institution on an average has 63% pass percentage. Program specific outcomes are visible through the change in the personality and the rise of confidence level. Yet beyond the curriculum and co curricular level, the programme outcome should be analysed further with reference to job opportunities and placements.

- 3.2.1. Incubation Centre and ecosystem for innovations and initiatives for creation and transfer of knowledge are yet to be established. However, the students take part in University sponsored Research Competitions "Avishkar." 12 Projects were presented and one was selected. Research surveys were also conducted on current issues like Impact of the Prime Ministers scheme for Rural development, Survey on Cashless transaction etc. In order to develop research culture and aptitude among the students research projects are assigned.
- 3.4.1. One unit of NSS is actively working in an adopted village. They have setup a Library for the villagers. Funds of Rs.1500 /- collected and given to the Adivasi needy Students, Rs. 4165 /- for National foundation for Communal Harmony, Rs. 5000 /- donated to suicidal farmers' children at Adhartirth Ashram. The students visited Mentally Challenged School, organized street plays on various social issues like save fuel and Beti Bachao, conducted awareness and survey about cashless transaction and use of swipe machine, participated in rally for computer and environment awareness. Lectures were conducted for the benefit of the Senior citizens.

- 4.1.1.The college is situated in 1.37Acre campus, functioning in 2493.71Sq.Mtrs. built up area. The institution has 18 well lighted and ventilated class roms, 6 ICT enabled class rooms, three seminar halls, a girls' common room. A Computer Lab with internet facility is available. Student Facility Centre is set up with computers with LAN and internet facility for sending online applications and other needs of the students. The infrastructue is shared with the Samastha's Junior College which resulted in shortage of space.
- 4.1.2. Courts for Volley Ball, Basket Ball, Kho Kho & Kabadi are there from the inception of the College. Yoga Centre was started in 2009. Indoor games facilities include Table Tennis, Carrom & Chess. Two seminar Halls are available to conduct cultural activities.
- 4.2.1.Library is partially automated and the process is ongoing. 52 Periodicals and Journals are subscribed. Shodganga subscription and access to e-journals are yet to be procured. It also houses the Student Facility Centre with 7 Computers, Printer, internet connection and photocopier. The library houses the Book Club maintained by the English students under "Earn while you Learn Scheme".
- 4.2.2.The library does not hold any rare books, Manuscripts or special reports which will enrich the library as "library hold for research pursuit." But they have collected and published the students' wall magazines under the title "Swayamsiddha." Very recently the library has added some Pali Books and Budhist literature and also some ancient religious texts like Srihari Vijay, Shivpuran, Adikmas Mahatmya. These manuscripts need to be preserved and digitalised.
- 4.3.1.Wi-Fi was initiated in 2016-17.Website is regularly updated. The college has a Lecture capturing system. It is running an online course in soft skills and Communicative English
- 4.4. Annual Maintenance Contract is in place for maintenance including updating and upgrading the Computers. Campus cleaning is done by the supporting staff. Requisition for maintenance is submitted to the Principal, placed before the Management and necessary steps are taken.

- 5.1 The college offers information regarding scholarship and freeship in prospectus and on website. Almost 70% of the total students avail scholarship and freeship from the Central and State governments. The college faculty raise DaiyatvaNidhi (Liability Fund) to the deserving students.
- 5.2 74.39 % of student progress to higher education. 18 students are qualified for the state/ national/ international level examinations. 305 students have appeared for the competitive exams. The college has established guidance center. 06 students have performed at national/international level and 144 at institution level in sports/cultural activities. The Alumni Association is functional contributes to the development of the institution. On an average, 30 sport and cultural activities and career guidance, soft skills, weaker section lectures, yoga training, personal counseling, student grievances. etc are organized.
- 5.3.2. The student's council of the college is constituted as per Maharashtra Public University Act. The College principal is the chairman of student council. The council consists of members nominated on the basis of merit Class representatives from each class, one representative from NSS, Sports and Cultural. Two representatives one from ST category and one from other are nominated by the Principal. Students council General Secretary elected from these members serves as the university representative.
- 5.3.4.Alumni Association need to be registered. It tries to help student placement counselling and gives feedback about the institution's infrastructure facilities and academic requirements. The association may proactively involve in the designing of future activities of the college.



- 6.1.1. Vision and Mission of the college focus on the upliftment and empowerment of girls from the educationally and socially backward communities. This is done through talent search competitions and co-curricular and extra curricular activities, under the leadership of the Principal who is given all academic freedom and also with the help of participative committees.
- 6.1.2. There is collective decision making in all matters through the participation of different committees. Student Welfare Department implements many proposals with the help of Co-ordinators.
- 6.2.1. Long term and short term perspective plans for the future development of the Institution are yet to be made.
- 6.4 College Development Council ensures the timely preparation and sanction of the Annual Budget of the

institute and sanctions grants for unassigned tasks/programmes. IQAC implements programmes, for students, the staff and other stakeholders of the education, as suggested by the CDC. The standard procedures of recruitment laid down by the UGC and the University are followed. Promotions are also given as per UGC rules according to the API score. Internal Complaints Committee as per the Visaka Guidelines is in place and the Grievance Redressal Mechanism also is operating.

Executive Committee of the Management includes teachers and industrialists. In a Women's College Women representation on the committee in minimal.

- 6.3.1. The institution offers effective welfare measures for the teaching and non teaching staff which include short and long term loan facilities, medical reimbursement, study leave, duty leave for attending conferences, Accident Insurance etc.
- 6.3.5. Self Appraisal forms are filled by the faculty and assessed by the IQAC. Students' Feedback on the performance of the teachers is collected before distribution of Self Appraisal forms to the faculty. Performance of the Non teaching staff is assessed by the Head of the department. There are many well educated members among the non-teaching staff, one M.Com. Degree holder is Accountant and one peon is a Ph.D. in Marathi. The office records and documents are well maintained. There is need for installation of computerised accounting software. The cash transactions of receipts and payments may be avoided as per the UGC directions.
- 6.4.1. Internal and external audits are conducted regularly. External Audit is done by Government Auditor General Panel (AG) sent by the Direcor, Higher education. University conducts audit for National Service Scheme and SWO and BCUD. There are no major Audit objections except some clarifications sought.
- 6.4.3. Student fees and Government grants are the main source of income. There is optimal utilisation of infrastructure facilities . The infrastructure is utilized for the courses of Yashwantrao Chavan Maharashtra Open University for MBA. Competitive Examination Guidance is provided on Sundays between 8 am to 2 pm. The infrastructure is used by the State and Central Government for conducting Various Competitive exams like MPSC, Staff Selection, and SET Exams. Bharat Natyam Dance classes are held between 06-10 p.m. in the evening four time a week. The Computer Lab is shared by the Junior college of the Management in the morning hours. The infrastructure is used for activities and programmes organised by the parent Institute and the sister concerns.
- 6.5.1 IQAC is mainly concentrating on the day to day academic activities like Time Table, Academic Calendar & Diary. It has to proactively participate in research activities and other quality enhancing and sustainable programmes.
- 6.5.2: There is need for periodic review of teching learning process and methodologies of operations and learning outcomes by IQAC. IQAC has initiated to conduct Academic & Administrative Audit involving external experts and steps may be taken to apply for government ranking under NIRF, UBA, SBA.
- 6.5.5 Many Quality Initiatives were implemented which brought the Best College Award of the University in 2015. Organized 02 National Seminars , 4 State Level seminars and a Two day University level Youth Festival of Pune University. Some MOUs were signed with NGOS like MUDRA, MITRA, Germany , and Jayam Foundation for NSS activities and Personality development programmes. One PG Course M.A. in Economics is introuced in 2013-14. The College has improved its ICT and Wifi facilities.


7.1.2.(a) The college is situated in a safe residential area. It is under CCTV surveilance.

(b)Independent Counselling centre gives free counselling for the needy students during college hours. Premarital and post marital counselling is given. With a well qualified Psyhology department more meaningful activities and short term courses in Counselling may be started.

- (c)There is a separate room for the lady staff and girl students room with washroom attached . Sanitary Napkin and wending machine is installed.
- 7.1.5. Solid waste and plastics are disposed in the Municipal waste collection tempo. E-Waste is given to the scrap wenders.
- 7.1.6 Rain water harvesting structures are yet to be constructed. Bore well water and Municipal supply water are in use.
- 7.1.7 Management Information System (MIS) for e-governance- communication with Management, University, UGC and MHRD is used. Many students and some faculty members use bicycles and public transport for commuting to the College. It is a plastic free campus. NSS volunteers have promoted cloth bags and paper bags.
- 7.1.18 Birth and death anniversaries of Indian leaders, and national festivals are all observed. Saree day, Selection of college Queen, etc. are attempts to preserve Indian tradition. Five day Ganesh festival is celebrated with Modak Competition. During Navarathri, Dandiya is performed. Rabindranath Tagore English Paper Presentation Competition and elocution competition on Swami Vivekananda are held.
- 7.1.19. The institution maintains complete transparency in its financial, academic, administrative and auxiliary functions.
- 7.2.1."Vivek Vahini" is one of the best practices in the college. The vision and mission of the college focus on the overall development of girls from the socially and economically backward neighbourhood. For the empowerment of this section of the region, the institute has introduced many programmes conducted through out the academic year under the banner "Vivek Vahini." since 2004. Vivek Vahini meetings are held regularly under the the guidance of the Coordinator where students paricipate in group discussions on current issues, and presentation of street plays on social problems. Vachan Prakalp is an important activity run under Vivek Vahini . in association with the District Divisional Library. Hundred books are issued every month and the students circulate these books among themselves and teachers. The students are to write reviews of the books they have read and discussions on the books read are also conducted in the meetings. This innovative practice has helped to nurture the habit of reading quality books, develop writing skills, build self confidence and improve the student teacher rapport. Students also get sensitised about various social problems.

Another best practice noticed in the institution is 'Dayitva Nidhi'. The scheme aims to provide needy and sincere students with support in the dire financial crises while pursuing studies. The fund for this purpose is raised from the contributions made by philonthropists and NGO s. The teaching and non teaching staff also donate Fifty rupees every month to this fund and it is deducted from their salary. The scheme is already notified in the Prospectus. The needy students apply for the financial help. The students who benefitted by this support are to return the money as and when they become financially sound. The scheme while preventing students from discontinuing their studies for want of money, also builds up their sense of responsibility and strengthens the bond with the college, student and teacher.

7.3.1.The activity of "Civil and Disaster Management" started in 2006. empowers the girl students through the training given to face emergency situations. Nirbhaya Kanya Abhiyan, fire fighting, first aid, traffic control, rescue services are some of the areas in which training is given through workshops and camps. This endeavour prepares the girls to be a force that can find solutions to the local problems in the hour of need.

The College is centrally located with experienced teachers;

It is the only women's college in the city. The Institution conducts many activities for the overall development of the girl students.

The affiliating University has adjudged the Institution as "Best College of the year 2014-2015"

The courses offered are very limited. There are only a few Job-Oriented short term Certificate/ Diploma courses;

There is space constraint for academic as well as sports activities

Infrastructure is shared with sister institutions under the trust/society

Low intake of students in many courses;

Drop out rate is high.

Opportunities:

Lot of scope for offering skill based job oriented courses;

Being a rural Women's College lot of opportunity to avail government schemes and UGC/RUSA funds for research and infrastrutural development

There are chances for placement activities with Industrial background of Nashik District;

Challenges:

Competition from the neighbouring Institutions of Nashik;

Improving the standard of First generation learners coming from Vernaular medium

Finding space for further expansion is a challenge.

Conservative Societal attitude about Girls and early marriage is a hurdle.
